**Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement**

Between NAME of VOLUNTEER (or parent if under 18) hereinafter called the “Releasor” and SOUTHWESTERN ONTARIO GLEANERS ORGANIZATION hereinafter called the Releasee”

Whereas the Releasee is a Not for Profit Charitable Organization whose objectives are to relieve poverty by drying

surplus fruit and vegetables on a volunteer basis and donate these products to people in need whether through human made, natural, economic or social disasters, both nationally and internationally;

And Whereas the Releasor is desirous of assisting the Releasee in achieving its objectives by drying surplus fruits and vegetable at the Releasee's facility on a volunteer basis;

Now Therefore in Consideration of the Releasee allowing the Releasor to become a volunteer for their organization, and for other good an valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties, their personal representatives, heirs and next-of-kin agree as follows:

1. The Releasor hereby releases, waives, discharges and covenants not to sue the Releasee relating to all liability for any and all loss or damage, and any claim or demands therefor on account of injury to the aforementioned persons or property or resulting in the death of the aforementioned persons arising out of or related to volunteering at the facility, whether caused by the negligence of the Releasee or otherwise.
2. The Releasor hereby acknowledges that by attending at the Releasee's facility and executing the is agreement, the Releasor consents to the Releasee utilizing the volunteer's image and likeness in any promotional material of the Releasee as the Releasee see fit in its sole absolute discretion.
3. The Releasor hereby agrees to indemnify and save and hold harmless the Releasee from any loss, liability, damage, or cost that may occur arising out of or related to volunteering at the facility of the Releasee whether caused by the negligence of the Releasee or otherwise.
4. The Releasor hereby assumes full responsibility for any risk of bodily injury, death or property damage arising out of or related to entering onto the property whether caused by the negligence of the Releasee or otherwise,
5. The Releasor hereby acknowledges that entering onto the property and volunteering in the facility can be dangerous and involve risk of serious injury and/or death and/or property damage. The above mentioned also expressly acknowledge that injuries received may be compounded or increased by negligent rescue operations or procedures of the Releasee.
6. The Releasor hereby agrees that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by the Releasee and is intended to be as broad and inclusive as is permitted by the laws of the Province of Ontario and if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

The undersigned have hereby read this release and waiver of liability, assumption of risk and indemnity agreement, fully understand its terms, understand that the Releasor has given up substantial rights by signing it, and have signed it freely and voluntarily without any inducement, assurance or guarantee being made to the undersigned, and intend by their signature give complete and unconditional release of all liability to the greatest extent allowed by law.
